The sorrowing parents were soon on the spot and the little fellow was taken home and prepared for interment. His limbs and body were entirely severed. Another accident with fatal results occurred at Townsville on the Delaware road, which is due at Townsend at 6 o'clock, was approaching the station, three men attempted to cross the track. One of them, Alex. Alfrey, was struck by the engine and knocked

several yards. Upon examination no bruises were found except one on top of the head from which his brain was oozing. The unfortunate man lived about an hour after the accident. He resided with his widowed mother near Green Spring, Del., and was 24 years of age.

NOTICE

To Hotel Keepers, and all Persons who Deal in Liquors.

For the information of all persons concerned, the following Act of the Legislature passed March 24th, 1883, is published:

CHAPTER 191.

AN ACT prohibiting the sale of spirituous or fermented liquors in the several counties of the State on the day of election.

SECTION 1. Be it enacted by the General Assembly of Maryland, That it shall not be lawful for the keepers of any hotel, tavern, store, drinking establishment, or other place where liquors are sold, or for any person or persons, directly or indirectly, to sell, barter, give or dispose of any spirituous or fermented liquors, or to mix or intoxicating drinks containing alcohol, on the day of election hereinafter to be held in the several counties of this State.

SECTION 2. And be it enacted, That any person violating the provisions of this act shall be liable to indictment by the Grand Jury of the county where the offence is committed, and shall upon conviction before any Judge of any of the Circuit Courts, or before the Sheriff, be fined a sum not less than fifty dollars, nor more than one hundred dollars, for each and every offence, one-half to the informer, and the other half to the County Commissioners for the use of public roads.

Noting on Election.

The attention of all persons is particularly called to the following section of Article 25, Code of Public General Laws of Maryland: "No person shall make any bet or wager on the result of any election to take place in this State.

47. Any person offending against the last preceding section shall be liable to indictment in the Circuit Courts, if in the county where the offence was committed, or in the Criminal Court of Baltimore, and on conviction shall be fined not less than fifty nor more than five hundred dollars, to be paid to the State for the use of the School Fund.

48. Every deposit of money in any part of the State in a wager or bet upon the result of an election, or if deposited in the city of Baltimore, to the Mayor and City Council.
