ORDER OF PUBLICATION

WESLEY H. WILSON, Plaintiff versus MARY MADELINE McGRATH WILSON, Defendant IN THE CIRCUIT COURT FOR QUEEN ANNE'S COUNTY IN EQUITY Cause No. 3466

The object of this suit is to procure a decree of divorce A Vinsulo Matrimonii by the Plaintiff, Wesley H. Wilson, from the Defendant, Mary Madeline McGrath Wilson.

This Bill of Complaint recites that the parties were married on October 19, 1942 at Centreville, Queen Anne's County, Maryland, while he was in the armed forces of the United States and that they saw each other as man and wife until sometime in the month of April 1943; that though the conduct of the Plaintiff towards his wife, the Defendant, was always, kind, affectionate and above reproach, the Defendant without any just cause or reason abandoned and deserted him, and has declared her intention to live with him no longer, and that such abandonment has continued uninterruptedly for at least 18 months, prior to the filing of this Bill, and said abandonment is deliberate and final, and the separation of the parties beyond any reasonable expectation of reconciliation; that no children were born as a result of the said marriage; that the Plaintiff is a resident of Queen Anne's County, Maryland, where he has resided for 2 years immediately preceding the filing of this Bill, and that the Defendant is a resident of Pittsburg, Pa.

IT IS THEREUPON, ORDERED by the Circuit Court for Queen Anne's County, in Equity, and by the authority thereof on this 29th day of January, 1946, that the Plaintiff Wesley H. Wilson, by causing a copy of this order to be inserted in some newspaper printed and published in Queen Anne's County, Maryland, once in each of 4 successive weeks before the 1st day of March, 1946 next, give notice to the said absent Defendant, Mary Madeline McGrath Wilson of the object and substance of the Bill of Complaint, warning her to be and appear in this Court, in person or by Solicitor, before the 18th day of March, 1946, next to show cause, if any she has, why a decree should not be as prayed.

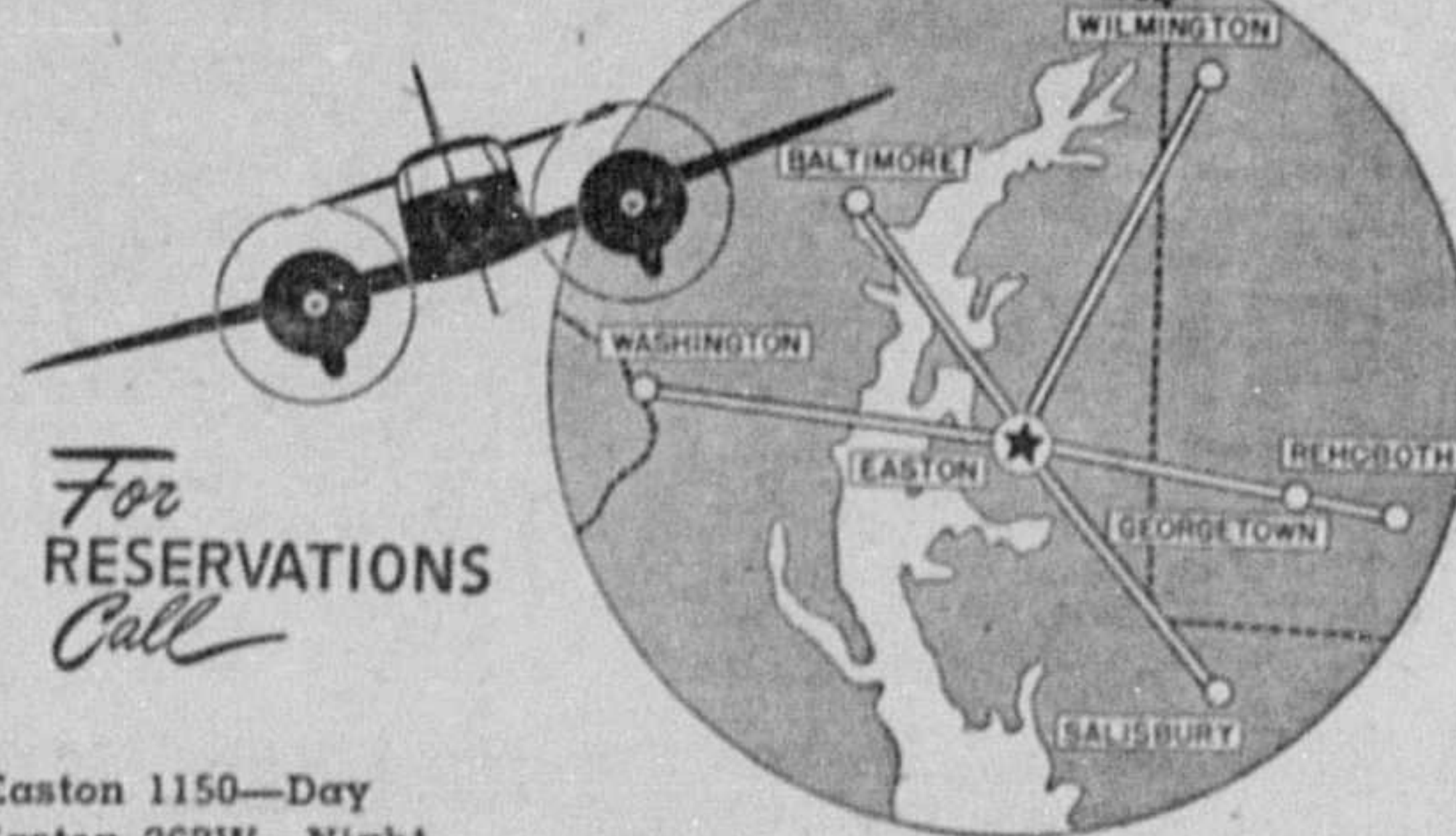

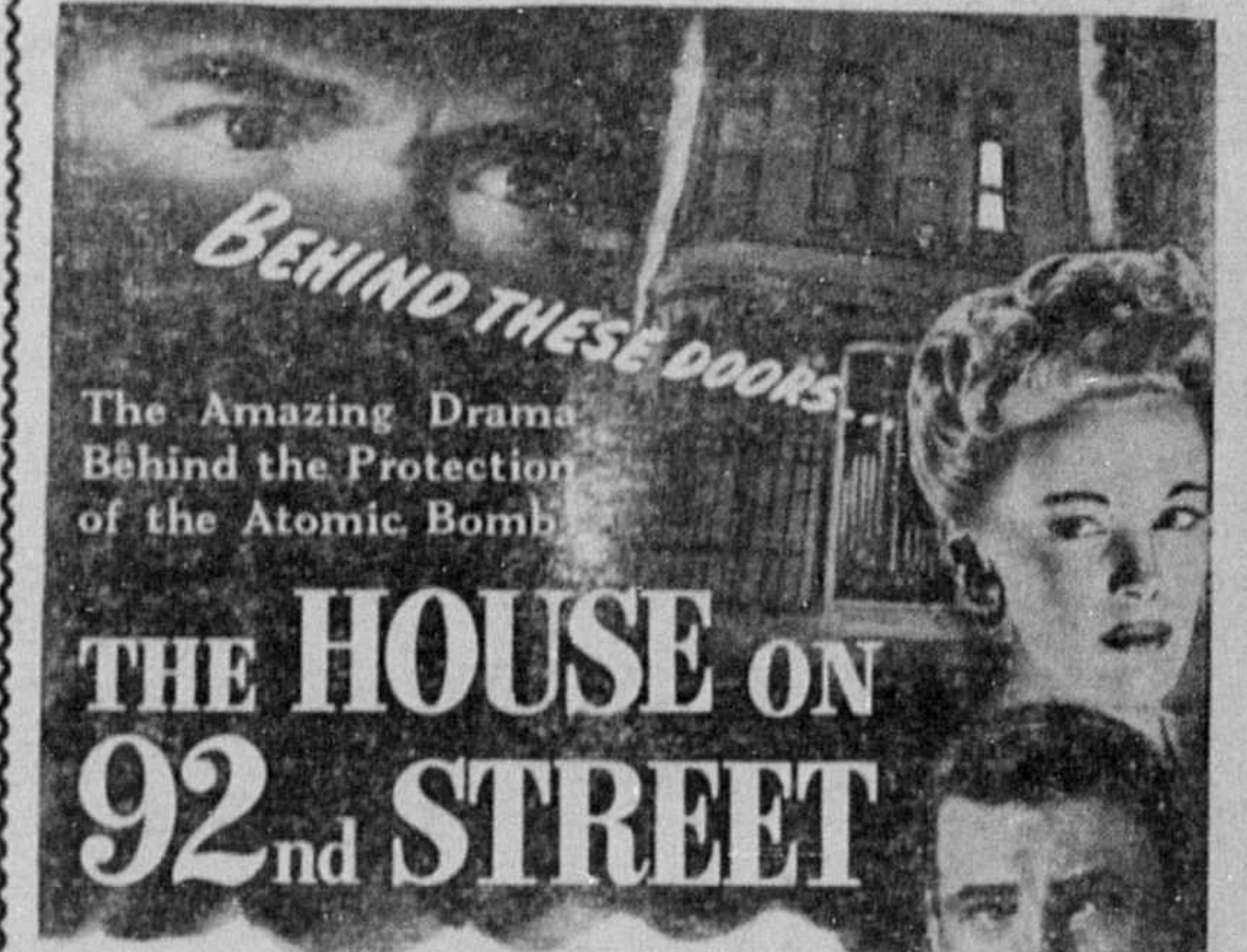
