We hereby certify that in compliance with the requirements of the law we have carefully examined this applicant, who states that he is suffering from the following disability, incurred

in the service, viz: G.S. of left hand & rheumatism & neuralgia in left hand & arm

and that he receives a pension of _____ dollars per month.

He makes the following statement upon which he bases his claim for Original [Original, increase, restoration, &c.]

Received G.S. of left hand at deep Bottom 0 1/2 in Spring of 1864. Sent to Fortress Monroe Hospital 3 months not broken out or suppurated since it originally healed but since that time it has been painful both in hand and arm. Rheumatism came on 4 yrs ago in left wrist and left shoulder. By neuralgia on order he refers to pain in hand and up the arm not broken out with rheumatism but has as much as six attacks each year lasting 3 days at a time.

Upon examination we find the following objective conditions: Pulse rate, 82; respiration, 18; temperature, 98.2; height, 5 feet 6 inches; weight, 132 pounds; age, 67 years.

G.S. of left hand. Ball entered on palmar surface of hand between thumb and index finger, opposite metacarpophalangeal articulation passing directly through the hand making its exit on dorsal surface opposite point of entrance in the interspace between the metacarpophalangeal articulation of thumb and index finger. Cicatrix is circular measuring 1/4 inch in diameter. Structures thickened but no other results. That is not tender, dragging, depressed, loss of tissue or injury to bone. Left hand over seat of injury is slightly smaller than right hand at same point. Left arm is atrophied one inch both above and below elbow. Neuralgia extending up left arm from seat of injury.

Rheumatism Left wrist Crepitant stiff swollen with impaired motion. Both shoulders both hips and both knees crepitant but no swelling stiffness contraction inflammation or impaired motion. Tongue fissured. Chronic granular pharyngitis with elongation of uvula. Skin affy conjunctiva normal. Stomach Bowels Rectum Liver & Spleen normal Lungs normal. Heart normal Apex impulse in 5th intercostal space in a line with

He is, in our opinion, entitled to a rating for the disability caused by G.S. of left hand & resulting neuralgia for that caused by rheumatism and 2/8 for that caused by chronic granular pharyngitis.
