# DECLARATION FOR PENSION.

THE PENSION CERTIFICATE SHOULD NOT BE FORWARDED WITH THE APPLICATION.

On this 22 day of February, A. D. one thousand nine hundred and Seven, personally appeared before me, a Justice of the Peace within and for the county and State aforesaid, Alexander Russum, who, being duly sworn according to law, declares that he is 64 years of age, and a resident of \_\_\_\_\_ county of Baltimore State of Maryland; and that he is the identical person who was ENROLLED at Camp Belknap under the name of Alexander Russum, on the 23 day of September, 1863, as a Private, in Co. B, 7th Reg United States Colored Volunteer Infantry (Here state rank, and company and regiment in the Army, or vessels if in the Navy.) in the service of the United States, in the Civil war, and was HONORABLY DISCHARGED at Indianola Texas, on the 13 day of October, 1866.
