SUPPLEMENTAL DECLARATION FOR INVALID PENSION.

Acts of June 27, 1890, and May 9, 1900.

who was ENROLLED on the 21 day of Sept., 1863, in B-7-

and regiment if in the army, or vessel if in the navy

in the service of the United States in the War of the Rebellion, and served at least Ninety Days, and was HONORABLY DISCHARGED at Balts. Md., on the 16 day of

Nov., 1866. That he was disabled for earning a support by manual labor in a pensionable degree on 1st May 1899, the date of filing his original declaration, by reason of the following disabilities:

Rheumatism, lumbago, rupture, affection of eye, pain in breast, right ankle affected and general debility

That he is also disabled for earning a support by an affection of the head when in the sun and he is unable to

Here state all disabilities incurred since filing your original declaration and any which you failed to allege in same

That said disabilities are not due to vicious habits, and are, to the best of his knowledge and belief, of a permanent character, and

that he is now partially disabled for earning a support by manual labor in consequence of same.

That he makes this declaration for the purpose of reopening his claim and being placed on the pension-roll of the United States, under the provisions of the Acts of June 27, 1890, and May 9, 1900. He also requests that his original or first claim filed under the said Acts, be re-examined and considered under the provisions of the Act approved March 6, 1896, and also under the decision of the Hon. Assistant Secretary of the Interior, of June 17, 1896, in the case of James J. Durkee, Vol. 8, P. D., p. 152, giving construction to said Act, and that he be given an opportunity to show by evidence that his claim, if allowed, should date back to the time of filing his original or first application for pension, under the Act of June 27, 1890. HE HEREBY APPOINTS, WITH FULL POWER OF SUBSTITUTION AND REVOCATION,

SOULÉ & CO., OF WASHINGTON, D. C., his true and lawful Attorneys, to prosecute this claim, and he directs that the sum of Ten Dollars be paid to said Attorneys.

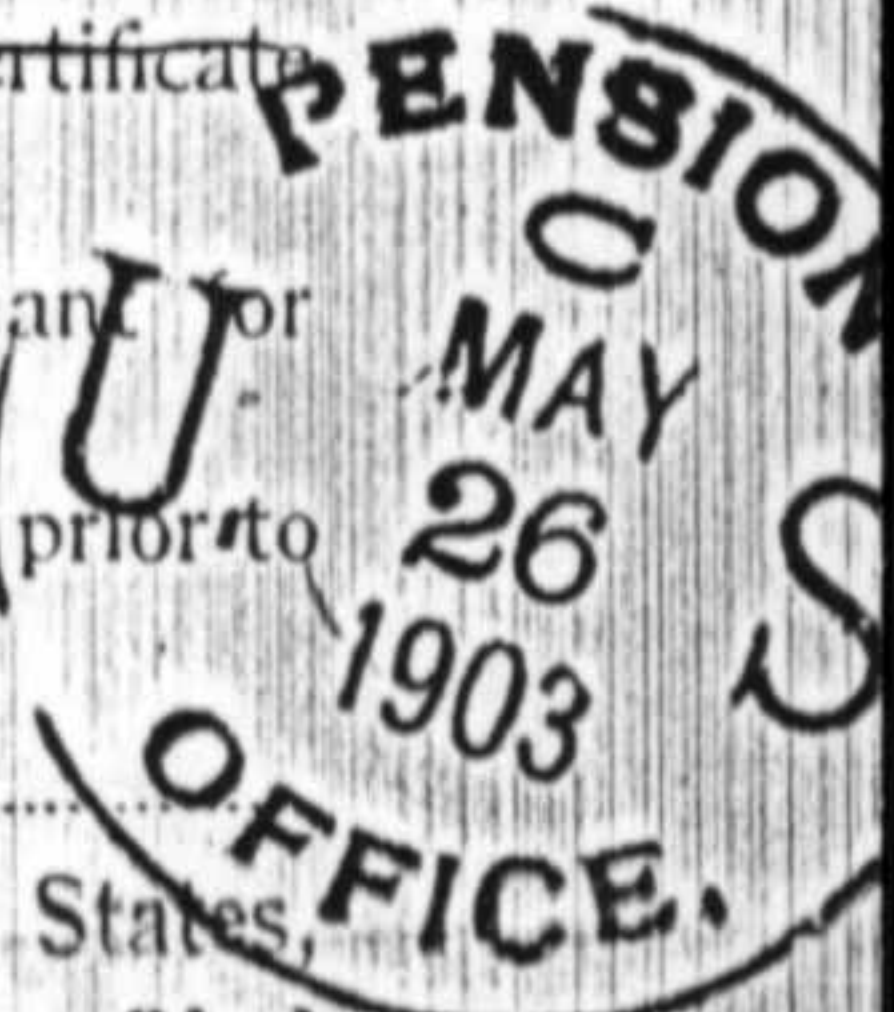
