IT is agreed between the MASTER, SEAMEN and MARINERS of the *of the Brigantine Tubrunner*
John Gump ^{Master} *of the Port of Baltimore* ~~Master~~, now bound for the Port of
Bowman

THAT in consideration of the monthly or other wages against each respective Seaman and Mariner's name hereunto set, They severally shall and will perform the above-mentioned voyage; and said Master doth hereby agree with and hire the said Seamen and Mariners for the said voyage, at such monthly wages, to be paid pursuant to the laws of the United States: And they the Seamen and Mariners do hereby promise and oblige themselves to do their duty, and obey the lawful commands of their Officers on board of the said *Brigantine* or the boats thereto belonging, as becomes good and faithful Seamen and Mariners; and that at all places where the said *Brigantine* shall put in, or anchor at, during the said voyage, to do their best endeavours for the preservation of the said *Brigantine* and cargo, and do not neglect nor refuse doing their duty by day or night, nor go out of the said *Brigantine* on board any other vessel, or on shore, under any pretence whatsoever, without leave first obtained of the Captain or commanding Officer on board; that in default thereof, they will not only be liable to the penalties mentioned in *An Act for the better regulation and government of Seamen in the Merchants service*; but will further, in case they should, on any account whatsoever, leave or desert the said *Brigantine* without the Master's consent, till the above-said voyage is ended, and the *Brigantine* discharged of her loading, be liable to forfeit and lose what wages may, at such time of their desertion, be due to them, together with every their goods, chattles, &c. on board; renouncing, by these presents, all title, right, demand, and pretensions thereunto forever, for them, their heirs, executors and administrators. And it is further agreed by both parties, that eight and forty hours absence, without leave, shall be deemed a total desertion, and render such Seamen and Mariners liable to the penalties above-mentioned. That each and every lawful command, which the said Master shall think necessary hereafter to issue, for the effectual government of the said vessel, suppressing immorality and voice of all kinds, be strictly complied with, under penalty of the person or persons disobeying, forfeiting his or their whole wages or hire, together with every thing belonging to him or them, on board the said vessel. And it is further agreed on, that no Officer or Seaman, belonging to the said *Brigantine* shall demand or be entitled to his wages or any part thereof, until the arrival of the said *Brigantine* at the above-mentioned Port of discharge, in *Baltimore*

That each Seaman and Mariner, who shall well and truly perform the above-mentioned voyage (provided always that there be no plunderage, embezzlement, or other unlawful act, committed on said vessel's cargo or stores) be entitled to the wages or hire, that may become due to him, pursuant to this agreement. That for the due performance of each and every of the above mentioned articles, agreement, and acknowledgment of their being voluntary, and without compulsion, or any clandestine means being used, we have each and every of us under affixed our hands, the month and day against our names affixed, and in the year of our Lord one thousand seven hundred and *1789*
