CHESTERTOWN FINANCES

The annual financial report of the Board of Town Commissioners for the fiscal year ended April 25 appeared in the News last week. On a taxable base of \$1,875,000, at an annual tax rate of 75 cents on the \$100, the total receipts amounted to \$24,022.70, including a balance of \$148.93 on hand from the report of 1926. The total disbursements were \$23,353.07, leaving a balance of \$269.63 with \$400 reserved for the payment of coupon on bonds due next July. The principal items of expenditure were: Payment of \$3500 on bonded indebtedness; \$2,638.75 interest on bonds; \$1,922.41 for labor on streets; \$2,551.23 for electric lighting and new sewers, paving and equipment for fire company. The total bonded indebtedness of the town is \$51,500, distributed in \$16,000 in street and sewer bonds, and \$35,500 for purchase and improvement of water system. The total receipts include \$13,320.20 collected in taxes during the year, the remainder having come from the Board of County Commissioners, the Water Board and other sources.
